Submission Details and Criteria:

- The Theme is "What is Contemporary Art?" see description on next page.
- This Juried Exhibition is an open call to Visual Arts Members of the Red Deer Arts Council
- Submit images for no more than three of your 2D and/or 3D works. (Max 1MB each)
- Only .jpeg/ .png digital files or USB stick will be accepted if mailed. HEIC files are not compatible with our computer systems.
- Please label your image filenames with the Title of the Work, Media, Date, Value for sale, and the Name of the Artist
- Number your images according to the listing in your completed Application & Declaration Form
- Complete, sign and submit only the Application & Declaration Form (Page 3)
- Works should be completed within the last two years and should not have been seen by the public in Red Deer.
- Artists who wish to propose new work not yet created may describe the proposed piece(s) and how they fit the theme and provide examples of previous work which shows the artist's style. In these cases, selection may be made with a stipulation that the final pieces must be approved prior to inclusion in the exhibition.
- All Submissions must be accompanied by a(n):
 - Artist Statement referring to the works submitted,
 - Artist Biography
 - o Curriculum Vitae (include your name in all files i.e. Benny Goodman CV).
- Late or incomplete submissions will not be accepted.
- Jurors will remain Anonymous, and the decisions made are final.
- Submissions may be sent electronically <u>submissions@reddeerartscouncil.ca</u>, or a hard copy mailed/delivered to the office. Please contact the office at the number above prior to visiting in person.
